SECTION 7: Handling and storage

7.1. Precautions for safe handling

Safe use of the product : Avoid exposure, obtain special instructions before use.

Ensure the complete gas system was (or is regularily) checked for leaks before use.

Avoid suck back of water, acid and alkalis.

Do not breathe gas.

stimulatory effects on the respiratory and circulatory systems.
